

Här får du vägledning hur du fyller i visumansökan inför resa till Indien.

Det är viktigt att du följer instruktionerna noggrant. För att ansöka om visum behöver du följande:

Pass

Ditt pass ska vara giltigt i minst sex månader efter ditt hemresedatum från Indien.

När du fyller i visumansökan behöver du en kopia av passets fotosida. Den ska laddas upp elektroniskt, så se till att ha kopian sparad på din dator. Filen måste vara i PDF-format och får vara högst 300 kB.

Passfoto

Du behöver ett aktuellt passfoto som laddas upp i samband med visumansökan. Fotot ska finnas sparad elektroniskt på din dator. Fotot ska uppfylla gällande krav för passfoton, vara i färg och får inte vara äldre än sex månader. Filen ska vara i JPG-format och får vara högst 1 MB.

Ansökningsformulär

En separat ansökan ska fyllas i elektroniskt på internet för varje resenär.

Uppgifterna i ansökan måste exakt överensstämja med uppgifterna i passet. Alla förnamn, mellannamn och efternamn ska anges precis som de står i passet.

30-dagars visum – 25 USD

1-årsvisum – 40 USD

5-årsvisum – 80 USD

Om du väljer 30-dagarsvisum ska du ansöka tidigast 25 dagar före din ankomst till Indien. Om du väljer 1- eller 5-årsvisum börjar visumets giltighet gälla från den dag då ansökan skickas in. Kontrollera därför att både ditt ankomst- och avresedatum ryms inom giltighetsperioden.


